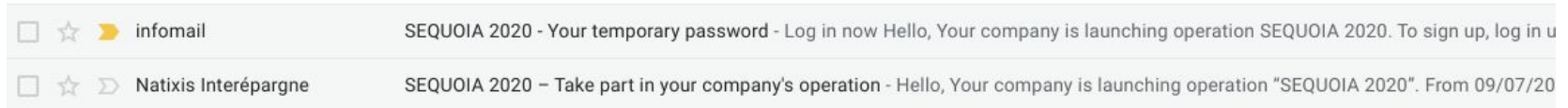


Subscribing to the Employee Share Plan Online
